Acquisition of title, rights and share by the Client is a transaction, as a result of which SE «Ditrade» shall assign the Title, rights and share for the Client's benefit based on the title, rights and share assignment agreement and accounting thereof (the public offer), entered into with the «URA» and the Client. The transaction shall be performed by way of transferring the funds from the Client's card account, opened in the Bank, using the Client's details.

3. Assignment of title, rights and share by the Client is a transaction, as a result of which «URA» shall acquire from the Client the Title, rights and share based on the title, rights and share assignment agreement and accounting thereof (the public offer), entered into with the «URA» and the Client. The transaction shall be performed by way of transferring the funds from «URA's» account to the Client's card account, opened in the Bank, using the Client's details.

4. The amount of the commission paid for the issuance of the official certificate may be returned to the Client in case if the certificate proves an error in the name and / or the Client's name.

<b>1. Carrying out payment transactions using a payment card</b> (using payment cards issued exclusively by resident banks of Ukraine)	1% + 5 UAH
<b>2. Execution of payments for transactions using a payment card</b> (using payment cards issued exclusively by resident banks of Ukraine) with the provision of an electronic document to the payee in the form of sms-message	1% + 6 UAH
<b>3. Carrying out payment transactions using a payment card</b> (with the use of payment cards, where the write-off transaction takes place from a payment card issued by Alfa-Bank, and the replenishment operation - on a payment card issued by a bank registered in accordance with the legislation of a foreign state (Note 5) and is a non-resident of Ukraine)	2% min 2 USD/EUR

The list of countries, according to the cards of recipients of non-resident banks of Ukraine, which is carried out the service "Transfer from card to card" and is determined by the relevant agreement between Alfa-Bank JSC and the individual in the provision of the service "Transfer from card to card".
